RESOLUTION NO. 2018-131**A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SURPRISE, MARICOPA COUNTY, ARIZONA DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON AUGUST 28, 2018 AND ORDERING THE RECORDING OF SUCH RESOLUTION**

WHEREAS, the City of Surprise did hold a Primary election on the 28th day of August, 2018 for the election of five (5) Council members; and

WHEREAS, the election returns have been presented to and have been canvassed by the Mayor and City Council.



SECTION 7: It is ordered that, directly following the adoption of this Resolution, the City Clerk shall record this Resolution with the Maricopa County Recorder's Office.


