RESOLUTION NO. 06-143

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SURPRISE, MARICOPA COUNTY, ARIZONA DECLARING AND ADOPTING THE RESULTS OF THE GENERAL ELECTION HELD ON NOVEMBER 7, 2006; AND ORDERING THE RECORDING OF SUCH RESOLUTION

WHEREAS, the City of Surprise did cause the following matters to be submitted to the qualified electors of the City at a General Election held in and for the City of Surprise on the 7th day of November , 2006 for one (1) Proposition 404; and

WHEREAS, the election returns have been presented to and have been canvassed by the Mayor and City Council.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Surprise, Arizona, that:

SECTION 1: The total number of ballots cast at said General Election was 24,126, distributed as follows:

SECTION 6: The total number of votes cast at said General Election on Proposition 404 was 24,126. 29 additional ballots contained over votes and 1,231 ballots contained under votes. The votes cast for Proposition 404 were as follows:

Proposition 404 – Permanent Base Adjustment


SECTION 7: It is ordered that, directly following the adoption of this Resolution, the City Clerk shall record this Resolution with the Maricopa County Recorder's Office.


